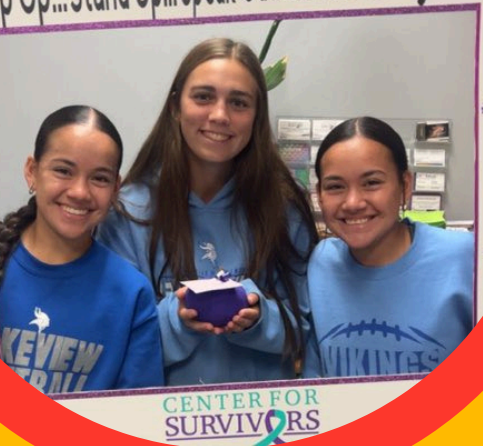

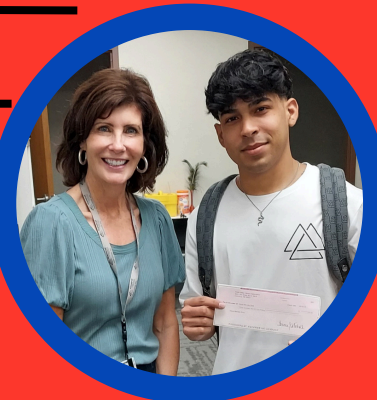

24 Pay Periods
