2020 LEADERSHIP

The adversity that our community faced in 2019 via the historic floods unfortunately merged into new challenges surrounding the pandemic in 2020. Despite all these circumstances, our community came together to support each other.

The Columbus Area United Way quickly raised over \$250,000 through the CoVid-19 Fund. That money was quickly infused into the community to offset some of the immediate economic and personal impacts felt by many, especially our more vulnerable population of senior citizens. In response to the pandemic, we also created impactful initiatives through our Fresh Bucks program and Mental Health Outreach Vouchers in partnership with Community and Family Partnership. These programs were created for a limited time to assist those in crisis through 2020 and are still being implemented today.

Thanks to our community annual campaign, 2019 campaign dollars were invested into the community in 2020 to more than 15 organizations assisting 5,985 people. In 2020, our community campaign raised \$816,000 to be distributed back to the local community in 2021 through 19 partner agencies. The United Way remains focused on improving the health, financial stability, and education of our community. The Board of Directors is also laser focused on being the first resource when emerging needs arise in our



communities. Our success is always because of people like you – the hand-raisers and doers who help to build a stronger, caring community through your advocacy, your support, and your volunteerism.

The 2020 Neighbor Helping Neighbor fundraising campaign took place during the COVID 19 pandemic. The Campaign team strategically prepared for a campaign season unlike anything in the history of Columbus Area United Way. Everyone knew there would be challenges communicating the needs of the United Way with people and businesses affected by the pandemic. Through the foresight and efforts of the Campaign team, a virtual campaign was developed and launched including a campaign toolkit, videos, and presentations. The Campaign team consisted of 27 Division Chairmen and 135 volunteers. Together they contacted 455 businesses and 347 retired community members to share about the local impact and investment Columbus Area United Way provides in the six-county service region of Boone, Butler, Colfax, Platte, Polk, and Nance. Once again, we are thankful for



the partnership and generosity of our Pacesetter companies and employees who raised 60% of the Campaign goal! 2020 Neighbor Helping Neighbor closed the campaign at \$816,000 to support local nonprofits focusing on Education, Financial Stability and Health.

Campaign 2020 Neighbor Helping Neighbor raised \$816,000 to support programming in the areas of Education, Financial Stability and Health. Mark Mercer served as Campaign Drive Chairman during this unprecedented year. With the onset of COVID-19 the Campaign team strategically prepared for a campaign season unlike anything in the history of Columbus Area United Way. The Campaign timeline was pushed back to start in September with the Pacesetter Company kickoff followed by the General Community Campaign in October. The Duck Race which typically took place in August at the Pawnee Plunge was held in December at the Columbus YMCA pool as a Duck Pluck!

Through the foresight and efforts of the Campaign team the Columbus Area United Way developed a virtual campaign toolkit and held virtual presentations throughout the campaign season encouraging community members about the importance of United Way funding to keep our neighbors and community strong and stable. 
